<u>Treasurer's Report</u>:

Don Heitler reported we have \$90,736 in our account. He will have to put in the actual on the budget and e-mail it to Carol, who will then e-mail it to the board for final approval.

Dick Duff was a guest speaker. He reported that the monies that were given to Tom Lenahan to get his teeth fixed, was returned by Tom's brothers (\$1,842). Dick suggested that we use this money as an educational fund for new players, to help them pay for lesions or pay for entry fees into club games. A separate account will be set up for the fund. Forest Clark will provide legal advice for the fund.

Committee Reports:
