 - How it has been running
 - Budget of \$2000
 - Mentee can play with mentor up to four times
 - Website structure is different than how it has been run
 - Objections to how it is defined
 - Mentor is not fully defined
 - Asking mentors to be a teacher
 - Earlier program
 - Meet with mentee and go over card
 - Ask mentee what they choose to get from program
 - Program was very structured
 - Committed to 6 sessions between March and November
 - Friday night game at sectional mentees and mentors played together
 - Clubs other than Denver Metro have not been participating
 - Many club owners did not know about the program's existence

- Six partnerships last year actually played together four times last year
- Suggestion that 500 points is too high 200 suggested
 - Voted on now limited to 200 points
- Suggestion that mentee/mentor commit to play four times, not a suggested four times
 - Some mentors may not commit to the program if there is a requirement of four times
 - Suggestion play together once and then determine whether or not compatible
 - Either mentee or mentor can approach coordinator and state they cannot work together

- Suggestion not to have a list of required discussion, should be a guideline
- Donna will draft a letter for mentees, mentors, club owners outlining the requirements

 - Preselling coupons/tickets
 - Hotel is providing the tickets
 - Any money left over will subsidize the lunch on Monday
 - Box lunch on Monday
 - Logo vote
 - Option 2 (Denver Skyline) approved
 - 6 trophies and 400 total prizes
 - Trophies for Pro-Am
 - Cost is about \$25 per trophy
 - Prizes for winning events
