- Sectional Preparation
 - o All of March applied to July
- Regional Preparation
 - Currently have 547 rooms booked
 - Last year at this time we had approximately 150 more rooms booked
 - People can cancel up to 1 day before their estimated arrival
 - There are typically many cancellations before the tournament
 - The unit has until April 28th to cancel with the hotel
 - A poll was taken on whether or not to cancel the tournament
 - It was moved, seconded and approved to cancel the regional now
 - o A discussion was held about possibly holding the regional later in the year
 - A poll was taken
 - It was moved, seconded and approved to skip the 2020 regional and not try to schedule another date
 - Cancellation plans

- Mentor / Coaching Program

- A unit wide, multi-club game to help clubs get back on their feet
- Currently there is an ACBL game on BBO where \$4 of the \$5 entry fee goes to the clubs
 - ACBL uses ACBL Live results to see where you normally play and distributes the money accordingly
