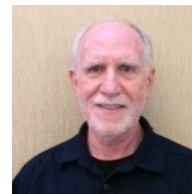

### Kibitz: It's All Risk Free

And there's an art to being a kibitzer. You can sit there and evaluate the hands, and decide upon your bid or line of play, and all at no risk whatsoever. You won't be the one ending up looking stupid. Of course, you can easily convince yourself that you would easily have come to the proper line of play even if you couldn't see one of the opponents' hands.

Marshall Miles once wrote, "Let's face it. A good game of duplicate bridge is rougher than anything you do for a living." He has a point. Most people are probably relatively comfortable

on their jobs. But at bridge you must make another bid or play, another decision, every few seconds. Your ego is constantly on the line. But not for the kibitzer in his ivory tower.

And of course, being a kibitzer can be hard work. Watching all the horrible things that take place. And you are supposed to hold your tongue. Good manners require that the kibitzer not comment. (Not all kibitzers have good manners.) You must be Marcel Marceau. No nodding or smiling, no frowning or scowling. It could give away information about the hand. Not even a chuckle can escape your lips. You can only think to yourself, "You're not going

to open that piece of junk, are you?"

As Menagerie author Victor Mollo once observed, "Kibitzers should be paid the proper rate for the job. Nobody should be expected to watch man's inhumanity to man at his own expense."
