

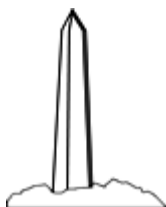

Jared Johnson Retires from Denver Post

When I started playing bridge in 1973, I soon met a young attorney from Georgia named Jared Johnson. In the mid 70's Jared began assisting Len Smith who was the bridge editor at "The Denver Post". At that time bridge had a large audience in the daily paper and Len Smith was an institution, an old curmudgeon, and to get "your name in lights" in one of his articles was a terrific thrill in Colorado bridge. When Len retired, Jared took over as editor and continued the tradition at the "Post" of actually writing news articles while a regional and most certainly any NABC (back then called a National) was occurring in our backyard.

Jared also became editor of District 17 Contract Bridge Forum Scorecard, which is the newspaper we receive every month, a position he held for about four decades. During that time he presented The Len Smith trophy and various other rewards to up and coming players. Jared also edited these daily bulletins at these tournaments for many years.

In the beginning the "Denver Post" bridge column appeared every Wednesday and Sunday, but then was cut to Sunday only. Finally Jared was told at the beginning of this year that the column would be discontinued, ending his work there in the fifth decade. With grace and style, he urged all of us not to burden the Post with letters, etc., pointing out his was the last local bridge column anywhere in the U.S. No paper could afford to do it with diminishing readership of the printed media.

Jared stopped being an active player a number of years ago. He has also retired from his work with the state of Colorado. If you see the headlines of the worst places on earth to live or visit, Jared has been there. Many of his old partners (including me) have begged him to come back to bridge. He has never lost interest in bridge but thus far will not play. How good a player is Jared Johnson? With all his years of inactivity, I only caught him in master points last year.
