The Denver Unit is on the Move!

As some of you may have heard, the Denver Unit is moving both its sectional and regional tournaments to new sites.

First, our sectionals are moving, beginning with our January 2001 tournament, to the Jefferson County Fairgrounds Auditorium. The site is located at 6th Avenue and Indiana Street, and is easily accessible from 6th Avenue, C-470 and I-70. While many of you may be thinking it's too far west, you just might be surprised at how easy it is to get there. A widening project on C-470 is almost complete, and resurfacing of 6th Avenue is near completion, so it should be clear sailing.

In addition to its accessibility, the auditorium offers a larger playing site, a large parking lot, larger restrooms and is within 5-10 minutes of perhaps 20 restaurants of all types. You can expect a better playing facility, free coffee and more hospitality provided by the Unit. In addition, the Jeffco Fairgrounds is two years into a ten-year renovation project which, when complete, will have parks, picnic areas, playgrounds, ball fields, a sale barn and more. Check it out, we think you'll like what you see.

In 2001 our regional tournament will be moving to the Renaissance Hotel on Quebec Street, near the former Stapleton Airport. It's easily accessed off I-70. The playing site is as nice, if not nicer, than the Hyatt, and best of all, parking is **FREE** right next door in a 510-stall garage. Room rates will be less expensive than the Hyatt, and we are told beginning in 2002 the Stapleton Redevelopment Project will provide lots of restaurants directly across the street.

We are excited about these new venues, and hope that you will be too.
