## DENVER BRIDGE NEWS

From Ruth Pana, Denver Unit 361 President

FALL 2008

This has been another record-breaking year for Denver Unit 361. Our Regional Tournament had 2,212 tables— 200 more tables than 2007. Over the Memorial Day week there were six regional tournaments sponsored by the ACBL.—Champaign, Il (751 tables), Minneapolis, MN (1,174 tables), New York, NY (1,330 tables) and Cleveland, OH (1,028 tables). Only Raleigh, NC (2,553 tables), surpassed our total. The Rocky Mountain Regional continues to be a great bridge-playing tournament. And a special thanks to Chairman, Jerry Newcomb; Charity Chairman, Barbara Webster; Partnerships, JoAnn Miller; Hospitality, Maxine Divine; Caddies, Carol Wendt (Carol just came aboard in May to take over the caddie responsibilities); Bulletin editor, Carolyn Newcomb; and the other Unit 361 Board members and unit volunteers who worked tirelessly throughout the regional.

In addition to the 2008 Rocky Mountain Regional we had sectionals in January, March and July and an Intermediate/Novice Sectional in April. All of the sectionals broke records with the July Sectional breaking the all-time record with a final table count of 537. The I/N sectional had 121 tables, another record-breaking attendance.

Unit 361 seeks to provide a wonderful bridge-playing experience. Lunch is provided daily at our sectionals with a catered lunch on Sunday for our Swiss Team players. The **Directors**, along with tournament chair, Don Boyarsky, supply chair, Lew Dorough, Hospitality chair, Maxine Divine, Membership chair, Merl Needham and Partnership chair, JoAnn Miller and other board members provide what we think is the **Best in the West**. The **caddies** assist the directors and the board and they are truly awesome. WHAT ENERGY!!!

Special Thanks to long-time board member, **Shirley Gates**, who is retiring from the board.



Shirley has been treasurer for the past three years. And thanks also to **JoAnn Miller**, Partnership chair for this past year and the 2007 Unit Board Secretary.






## **Maxine Divine**

# A LOOK AT THE WORLD OF DOUBLES

Players new to the duplicate scene may be overwhelmed by the extensive use of the word "double" in competitive auctions. Rarely, is the double meant to be for penalties. The challenge, therefore, is for a partnership to agree on the meaning of the double within the context of the auction. Even experts disagree on the fine points, as noted in the August Bridge Bulletin article, "Your Call." The word take-out, is exactly as implied. Take me out of this bid, unless you can set the opponents. You must have great length and strength in their suit to pass.

Low level doubles of suit bids are for takeout. If partner doubles and the opponents bid and partner doubles again, the repeat of the double is still for take-out. In fact, if the opponents have found suit agreement below the level of 2NT, there is a very good chance that a part score can be made by the side that hasn't bid yet. Therefore, a double in balancing seat asks partner to bid and should not be construed as penalty. The point count requirement for a first round double need not be met. If you bid or overcalled and partner did not respond, a double still asks him to bid. This double is not for penalty. In these situations, the person who doubles does not have the suit that has been bid.

**Doubles of preemptive bids** are for takeout. The partnership must decide how high. (What does a double of a 4 spade opening bid show?)

**Doubles of artificial bids** tend to be lead directing. Common low level artificial bids

are Stayman and transfers after NT openings. Doubles of these bids imply length as well as strength, as partner may elect to compete when the opponents want to play at a low level in their suit. A double of the answer to Blackwood, or a cue bid on the way to slam implies the ace or king and asks for the lead of that suit.

Penalizing the Opponents with Penalty doubles of low level contracts can be extremely rewarding. However, by partnership agreement, direct doubles of low level suit contracts are for take-out. How, then, can the opponents be doubled for penalties? The partner of the person who doubles, passes, and thus converts the take-out double to a penalty double.

Partner has opened with a suit, and RHO makes a suit overcall. In order to look for penalties, you must have a long and strong holding in the overcalled suit, 8+ high card points, and a misfit with partner's suit. If you are playing negative doubles, your pass is forcing and when partner re-opens with a double, you pass. He may elect to bid a suit if his hand is not suitable for defense.

Partner has opened with a suit and RHO overcalls 1NT. A double here is a penalty double. You must have at least 9 high card points, a fit with partner or a good suit of your own to lead. Dummy should have very few points. Declarer will have to play everything out of his hand. (Note: suit bids in this auction are nonforcing and competitive. A raise of partner's suit is also competitive and shows a bad hand with little prospect of game or defeating 1NT.




