SPRING 2009



Appreciate the Little Things

When evaluating one's hand one must appreciate the value of minor honors, especially in a suit that partner has bid. Let's say that partner has opened 1S and you have

xxx, Axxx, Qxx, Q109.

You bid 2S and partner bids 3C (game try, of course). Despite the always-useful A, and the club help that partner is asking for, you should bid 3S and decline partners's invitation because your hand has 2 big flaws- bad shape, and awful spades.

If partner has, say, AQ9xx, KJx, x, KJxx, he will be happy not to be higher. Just looking at the spade suit, he will have to be quite lucky not to lose more than 1 spade trick. If, on the other hand, your spades were, say, J10x, he needs only a finesse to not lose any spades tricks at all.

Similarly, if his spades were KJ8xx, he could easily lose 3 trump tricks with a little bad luck if yours were 3 small, but if yours were as little at 109x, then he might well lose only 1 trump trick with a successful finesse.

The point is that those minor honors can make a huge difference if partner's trumps are not solid. You will do well to NEVER make any aggressive moves with 3 small in partner's suit.

As one more example, let's assume partner has opened 2S, and you have a singleton S, but otherwise a good hand. As most players know, it is best to not bid very much here, since even if partner's spades are decent (say, KQ107xx), if he is a little unlucky, he could easily lose 3 tricks in spades alone.

If , on the other hand, your singleton spade is the Jack, he would have to be unlucky to lose more than 1 spade trick. In this situation, any singleton higher than the 9 is likely to be a useful card.

If partner has, for example, KJ9542 and you had a singleton 10, that alone makes it unlikely that partner will lose more than 2 trump tricks.

The little things are important and should help you decide how aggressive to be


