- Costs are increasing

We have taken the following steps to try to balance our budget:

- Eliminate Thursday night at the sectionals
- Eliminate the free lunch on Saturday at the sectionals
- Publish the directory every other year
- Distribute Table Talk electronically only

July 2016 was the test sectional, and we're happy to report that the unit made a modest profit.

# **GNT? NAP? STaC?**

## Jim Calhoun, Membership Chair

There are several abbreviations floating around in bridge circles that could use some definition.

#### **GNT-Grand National Teams**

To start, your team must play in and qualify at a club of your choice holding a Swiss Team Game. Check with clubs for dates and times of qualifying games. Once qualified, you may compete at the regional level at the appropriate regional tournament in District 17. At the regional, you will compete for a chance to play for the national title. The national competition is held during the summer NABC.

There are four flights in the GNTs:

- Open (unlimited points)
- A Flight with any player not having more than 6000 points
- B Flight with any player not having more than 2500 points
- C Flight with any nonlife master not having more than 500 points.

Winning teams may qualify for a stipend to help offset the cost of competing at the summer NABC (see conditions of contest at ACBL).

## NAP-North American Pairs (was NAOP, North American Open Pairs)

Each club can hold two NAP (North American Pairs) games per sanctioned session during each of the months of June, July and August. These games award 100% sectional-rated half red/half black masterpoints. This grassroots event is staged in qualifying rounds at the club, unit and district levels. It culminates in a final held in conjunction with the spring NABC.

The contest is run as a stratiflighted event:

- Flight A (Open)
- Flight B (fewer than 2500 masterpoints as of the June masterpoint cycle)
- Flight C (Non-Life Master with fewer than 500 masterpoints as of June)

Please check your June Bridge Bulletin for your masterpoint total.

Winning pairs may qualify for a stipend to help offset cost of competing at the Spring NABC (see conditions of contest at ACBL).

#### STaC-Sectional Tournament at Clubs:

Sectional Tournaments at Clubs (STaCs) provide bridge players with the opportunity to win silver points at their local clubs. The same hands are played across multiple clubs, and district-wide results are computed.

Players can win:

- Black points for club results
- Silver points for district-wide results

# FROM THEN TILL NOW

1370 members and \$81,000 in the bank.

These figures represent the current membership and financial position of the Denver Bridge Unit of the American Contract Bridge League. This organization exists for the purpose of promoting and conducting activities designed to enhance the growth and enjoyment of competitive contract bridge. In a recent discussion concerning the status, welfare, and goals of the Unit, the current president, Margaret Devere, asked if I could compose what she called

a "retrospective," reciting some of the history that has led the Unit 361 from its non- existence to where it is today. I agreed to try.

No firm information on the first duplicate bridge games in Denver is available. There were club games being played on the date of the assassination of President JF Kennedy on November 22, 1963. At least two clubs were located in the old Sears complex at what is now the site of the Cherry Creek Shopping Center. The Denver Unit was probably in existence at that time, sponsoring sectional and regional

tournaments. On September 21, 1976, I filed Articles of Incorporation under the Colorado Nonprofit Corporation Act subject to the state's law and the rules of the IRS. No mention in those papers was made to "Unit 361" and I assume that number was later assigned by the ACBL. Members of the original Board of Directors included Don Heitler and Lois Scott (now Lois Schmied), who are still members of the Unit.

Prior to the incorporation things are a bit less remembered. At least two clubs were functioning at that time: the aforementioned club in the Cherry Creek area, owned and operated at different times by Bill Puryear, Bob Baptist, and Maxine and Jim Chambers, and a club known as the Bridge Center, located at the intersection of I-25 and Evans. The Bridge Center was owned by Bill Fox, who purchased it from Claude and Nadine Potter. Bill operated that club (mostly at a different location) until 1980 when he embarked on a new career as a director specializing in overseeing bridge cruises. Bill says that he spent over 8000 nights at sea acting in that capacity prior to his retirement a few years ago.

Bridge was flourishing in that era. Clubs appeared in other areas of the city and suburbs: Arvada, Littleton, Englewood, Lakewood, among others. Owners and directors included Helen Jenkins and June Holbrook. More and later clubs and owners came along later and added their contribution to the bridge community.

In 1965, Denver's first home-grown national champion graduated from Thomas Jefferson High School and began what has been a remarkable bridge career. Jan Janitschke and his younger brother, Craig, became the most formidable partnership in the area, winning events at sectionals and regionals with regularity. The brothers won a National Team event in Chicago before Craig moved to Washington State where he became a regular and successful partner to the legendary Barry Crane. Denver has had other national champions—Chuck Henke, Danny Mordecai, Jack Bitman, Dick Lesko, Patty Norman, perhaps others, most of who got started in the Denver area in the 1970s. Chuck Henke was the exception. He won the Blue Ribbon pairs in 1965 before he immigrated to Denver. In the present day, national champion Brad Mass is living in Denver.

Masterpoints were recorded in a different manner in those times. All points won in tournaments were awarded by and recorded with the ACBL headquarters. All points won at the club level were issued to the players on a receipt-like form. The form was approximately twice the size of a common business card, and almost always, the number of masterpoints won at a time was less than one. To receive credit for the points, the individual player had to send the forms by mail to the ACBL offices. During that period, Len Smith, bridge writer for the Denver Post, caused the names of the three top finishers in the club games to be published



in the Post. This may have been in furtherance of a misguided attempt to give recognition to Contract Bridge as an Olympic Sport.

Len contributed to the advancement of Denver Bridge in other ways. For several years he promoted an annual bridge game where a busload of Denver players would travel to Canon City and play a two-session event at the state prison with inmates from there, participating in what had to be a welcome diversion from their daily routine. Len was succeeded at the Post by Jared Johnson who ardently wrote about Denver Bridge for decades until the Post succumbed to modern day economics and, as a cost-cutting measure, eliminated the local coverage of bridge.

Statistics relative to membership and finances for that interim are difficult to assemble. We know that in 1976, there was sufficient interest among the playing group to support incorporation. Prior to the incorporation, the Unit had been staging sectional and regional tournaments and performing other duties inherent to bridge competition. One of these duties was to compile and publish annual membership directories. The oldest of these that could be found is the directory for the year 1996. The cover of that directory was designed by Beth Nelowet, who still plays. The booklet lists approximately 1200 members, some 200 of whom are still active, starting with A (Bill Allegar) and ending with Y (Ernie Young, who still has the same address). Membership has fluctuated but remained fairly constant up to and including today's date.

Unit finances have not been quite so steady. While the current bank balance of \$81,000 is sufficient to cover us in the event of some unforeseen catastrophes, the present conditions have not always been so good. There was once a time when one of the Unit's presidents made a personal loan to the Unit so that current expenses could be met. That occurred either just before or just after the incorporation.

#### From Then Till Now (continued)

Since that loan (which has been repaid ©), the Unit has had a sound financial record. Income comes from membership fees (a portion of the membership fees paid to the ACBL are remitted to the units) and entry fees at the Unit-sponsored sectional and regional tournaments. Historically we have made money on the Regional—it is the source of about half the Unit income—and have sometimes made money and sometimes lost money on the Sectionals. In the past two or three years we have lost money on the Sectionals, causing the present board to address and to take cost-cutting steps to correct that trend. Circumstances beyond the control of the Unit, such as bad weather or a special Broncos game, can affect attendance enough to determine the profitability of a Sectional.

The annual Rocky Mountain Regional has been held at many locations over the years: the Regency Hotel (the tall circular building north on I-25, repurposed several times over the years and maybe now a student dormitory), the Merchandise Mart, the Hyatt Regency Hotel in the Denver Tech Center, the Renaissance. All were great locations at the time. Costs continue to rise, possibly forcing us to consider new locations in the future, but the Memorial Day Regional will continue to be a focal point of the Denver Unit.

A couple of facts about the Regionals: (1) We as a group have been asked to leave two tournament sites, once because our players continued to wander into restricted areas despite being warned that such activity could lead to expulsion, and once because a group of smokers set off a fire alarm while smoking in a stairwell. (We also lost a Sectional site when a smoker went to sleep lying on a couch and the couch caught fire.) (2) Our annual Regional was at one time held over the 4<sup>th</sup> of July rather than Memorial Day.

The progression in Denver Bridge has been rather steady in the last forty years. The club owners mentioned earlier have for the most part disappeared from the scene and a newer group has kept the lifeline of bridge-the clubs-active and progressive. In 1980 Mike Thompson opened his club on South Broadway in Denver. He has operated a club ever since that date at various locations-Santa Fe Drive, Littleton, Colorado and Evans and his present location on Leetsdale Drive. Also in 1980, Bill Fox sold his club and a line of successors followed: Allen LaTuchie, Mike Radcliffe, and Marvel Heinsohn. Add to this list Paul Ossip who currently owns the largest active club in the Denver Area. Other owners who have made significant contributions to bridge in Denver include Sharon Wells, Virginia Gunter, Warren Garrett, Mary Ann Pixley, Joe and Virginia Sewall, Robert Kelly, June Holbrook, Helen Jenkins, Georgia Wilson, Steve Wainz, and many others whom I may have forgotten to mention. All of these individuals have contributed much more to the game of bridge than they have received in compensation. They all should be applauded and commended.

One last bit of trivia—Bill Fox at one time instituted a policy of providing free beer to the players on Thursday night. This happened on only two or three occasions; then the officials of the City and County of Denver declared that such a procedure constituted the offense of selling liquor without a license and put a halt to this innovation.

We are where we are. Denver Bridge faces the problems of an aging constituency, internet alternatives, and rising costs, all of which will probably be solved in the future as other problems have been solved in the past.

Leastways, all have been solved up till now.

We got here.
