#### En Hay reaches 20,000

En was born in An Khe, South Vietnam, where she met her future husband and had three daughters. Once her daughters were grown and married, En decided to find a hobby or two and bridge was one of them.

When the couple moved to Denver in 1990, En had amassed 90 master points—and so began a 34-year bridge odyssey. In 2024, En became the first female Colorado ACBL member to achieve 20,000 masterpoints. She has many other bridge accomplishments, including five Colorado Victory Trophies, over 100 blue and silver ribbon qualifications, and over 30 various Ace of Clubs and Mini-McKenney wins to her credit.



Currently she is the 28th woman on the ACBL Lifetime Top 500 and 153rd among living ACBL members. Needless to say, she's still going strong!

Congratulations to En on all her accomplishments and on becoming a Platinum Masterpoint holder!

# **Fall Open Sectional**

Fall is in the air and we hope the 90 degree weather is behind us for the year!

Come Play in Denver's Fall Sectional on November 1-3, 2024. Lunch for \$5 on Friday and Saturday!

Open Sectional (Silver Points) held at Iliff School of Theology, 2323 East Iliff Ave, Denver.

Schedule: Two-session pairs games on Friday and Saturday at 10:00 and 2:30 with accommodation for single sessions. Sunday two-session playthrough team games starting at 10:00.

IMPORTANT Parking Information: Paid parking is available in many locations that have kiosks. Be sure to have your license plate number and a credit card handy when you get to the kiosk. When you use a kiosk, make sure it is for the lot where you have parked, or you will be ticketed. It is easier to pay for parking using the ParkMobile App than using kiosks. You can download it to your smartphone from your App Store (no cost).

If you have a physical limitation, you can park in Lot B directly in front of the Iliff building. Pay at the kiosk near the building entrance.

More parking is available near Iliff School of Theology. Turn west onto East Iliff Ave (from University), go past the parking lots on the right then turn right on Gaylord St. There is kiosk parking in the row of spaces along Gaylord St, Lot 304. Or you can take a quick left into Lot H1 where a volunteer will take \$10 and hand you a voucher to put on your dashboard. They only accept the exact amount.

Lunches: Sunday lunch is included in the team fee. Friday and Saturday you can buy lunch for \$5.

   Whoops, out of snacks? Let's add more! We ran out of cups and now someone needs to find more in a crate!)

We have seven major tournaments each year (four Open Sectionals, two 499-er Sectionals, and our week-long Memorial Day Regional Tournament).

The workload has become overwhelming and we need more volunteers to help. Can you find a group of volunteers to share duties--no need for one person to do it all. As we all know, many hands make light work. Thanks in advance for helping us field our Bridge Tournaments throughout the year.

### **UNIT 361 DIRECTOR INITIATIVE EXTENDED**

Unit 361 encourages any unit member to become a qualified tournament director – we always prefer to work with local directors if we can. To that end, for the remainder of 2024 and through 2025, Unit 361 will continue sponsoring a Director Initiative. The unit will reimburse your costs for director course materials and director tests, once the test is passed.

Here is a quick description of the various forms that bridge directing can take, along with information on getting started. If you are interested, email the president of Unit 361 to inform us of your plans, and keep the unit posted as you progress.

#### What and How

- Club Director: Qualified to direct games at any club, to direct Intermediate/ Newcomer tournaments, and to direct bridge games on cruises. Materials are available from Baron Barclay. Watch here for online course dates: <a href="https://www.acbl.org/portfolio/director-courses/">https://www.acbl.org/portfolio/director-courses/</a>. The course fee including test is \$50; test only is \$15. Compensation is by agreement between the parties.
- Tournament Assistant: Qualified to be hired by a local tournament organizer to help out at a sectional or regional tournament. People who have passed this test are generally approved to run an Intermediate/Newcomer sectional tournament. There are no materials or training program. The test fee is \$50. For more information about the test, contact Tony Greene: tony. greene@acbl.org. Compensation is by agreement between the parties.
- Local Sectional Director: Qualified to run Local Sectional tournaments (a new tournament type). Must be qualified as a Club Director or Tournament Assistant, then pass the Local Sectional Director test. Go here for more information and to register: <a href="https://www.acbl.org/portfolio/director-courses/">https://www.acbl.org/portfolio/director-courses/</a>. Materials are provided after registration. Compensation is by agreement between the parties.
- ACBL Tournament Director: Qualified to direct events at sectional, regional, and national tournaments (depending on experience and seniority). It is not necessary to be a club director first. In Unit 361 (and the rest of the western USA), interested persons should contact Matt Koltnow: <a href="matt.koltnow@acbl.org">matt.koltnow@acbl.org</a>. The applicant must pass a test and an audition, both free. Compensation starts at \$16/hour, and expenses (transportation/mileage and per diem) are covered.

#### Election for the 2024–2025 Unit Board

Unit 361's election for the 2025–2026 term of the Board of Directors will be held on November 2, 2024 during our fall sectional.

A nominating committee met in order to submit candidates for the upcoming election. The members of this year's committee were Don Boyarsky, Donna Givner, Denise Klein and Mike Crimmins.

There are five positions open for the 2024–2025 Board. The committee believes the candidates listed here are excellent choices to run for the Board of Directors

If you are interested in running for the board ...

Anyone who would like to run for the Board of Directors can petition the Board to join these candidates on the ballot. A petition signed by at least ten members in good standing in Unit 361 must be submitted to the Board of Directors at least two weeks prior to the election. The deadline for submitting such a petition is October 21, 2023. In the event such a petition is received, paper ballots will be printed with anyone who successfully petitioned to be on the Board and the five candidates listed below. Voting will occur on November 2, 2024. The five people receiving the most votes will be elected to the 2025–2026 Board of Directors.
